

# City of Rocky River & City of Bay Village FIREFIGHTER/PARAMEDIC

Thank you for your interest in the City of Rocky River & City of Bay Village Fire Departments. The Cities' Civil Service Commissions are holding a joint competitive written exam for the position of Firefighter/Paramedic; your online application will be considered by BOTH Fire Departments. Applications are being accepted for the purpose of filling future openings and to establish eligibility lists for both cities. Please read this document carefully, paying particular attention to deadlines, minimum requirements, and required documents for EACH department.

#### MINIMUM REQUIREMENTS:

**Fee** • \$35.00 non-refundable application fee.

Age • Rocky River: At least 18, but less than 36 on date of appointment.

• Bay Village: At least 18, but less than 32 on date of appointment.

(Candidates who are 32, but less than 36 will ONLY be considered by the City of Rocky River.)

Citizenship

U.S. Citizen, have legally declared intent to become a U.S. Citizen, or permanent resident.

**Education** • High School diploma or equivalent (GED).

**Licenses** • Must have a valid Ohio Driver's License.

Physical Agility Test Certificate from Cuyahoga Community College (CCC) valid as of June 27, 2009 AND at time of appointment, if any. Register to participate in the CCC physical agility test held on May 31, 2009. \*Standard: 4.5 minutes to complete all tasks.

**Residence for** • **Bay Village:** If appointed, must reside within a 20 mile radius within two (2) years. **Bay Village** 

**EXTRA CREDITS:** Extra credits shall be granted to candidates only after passing the written examination with a score of 70% or higher and who submit all supporting documentation by application deadline. Documentation submitted for extra credits shall be current and valid on test date. (See page 2 of this document for more information and details for both cities.)

#### **APPLICATION INSTRUCTIONS:**

- 1) Visit <a href="www.publicsafetyrecruitment.com">www.publicsafetyrecruitment.com</a> to complete the online application for the position of Firefighter/Paramedic. Applications must be completed and confirmed by noon on June 12, 2009. You will receive a confirmation number when you complete your online application. Save this number for your records.
- 2) Return signed release form and all other required documents (see checklist) BEFORE noon on Friday, June 12, 2009 to Public Safety Recruitment, Attn.: RR/BV, 1127 S. Mannheim Rd., Ste. 203, Westchester, IL 60154. Applications received after 12 NOON on Friday, June 12, 2009 will not be accepted. Faxed and postmarked release forms will not be accepted. Sending release forms and other requested documents via traceable courier is highly suggested to ensure timely delivery.
- 3) Register to participate in the FIRE Physical Agility Test with Cuyahoga Community College (CCC). Testing will take place on Sunday, May 31, 2009. Contact CCC Fire Training Academy at (216) 987-5429 to register. Physical Agility Test Certificates will be considered valid if issued between 6/27/2008 and 6/27/2009. Standard: 4.5 minutes to complete all tasks. More information on the Physical Agility Test at CCC provided at the end of this packet.
- 4) Attend Written Exam on Saturday, June 27, 2009 at Bay Village High School, 29230 Wolf Road, Bay Village, OH 44145. Arrive at 8:30 AM with your Valid Driver's License or State ID to sign in. Testing will take place from 10:00 AM 12:30 PM in the Cafeteria. Fingerprinting will also be conducted on test day. Public parking available

The discovery of any knowingly false statement will be regarded as good cause for excluding the applicant from the examination, or for removing his/her name from any eligibility list, and may result in referral of the incident to law enforcement authorities. All portions of the testing process are mandatory. Failure to attend and successfully complete any portion of the process will result in elimination from employment consideration.

#### **EXTRA CREDIT**

Following the release of the initial written exam scores, the cities will adjust the scores for extra credit, separately under their own rules and regulations, which are summarized below. EACH CITY WILL THEN ESTABLISH ITS OWN SEPARATE CERTIFIED LIST BASED UPON SUCH RULES AND REGULATIONS.

#### **IMPORTANT:**

- Candidates MUST submit two (2) copies of required Extra Credit Documentation indicating the City for which they are requesting extra credit.
  - Documentation for Extra Credit MUST be submitted at application deadline AND shall be valid and current on test day.
    - Candidates must achieve a passing score of 70% or higher to qualify for extra credits.

#### **ROCKY RIVER EXTRA CREDITS:**

Extra credit documentation may be submitted for a maximum of 20% of the written test score. Percentages will be applied to the test score of candidates with a passing grade on the written exam to establish the final adjusted test score. A passing score of 70% or higher on the written exam is required to qualify for extra credit.

<u>The 15 candidates with the highest adjusted scores</u> will proceed through additional further testing at the discretion of the Rocky River Civil Service Commission and the Fire Chief. Additional further testing may include interview, polygraph test, background investigation, psychological exam, and physical exam including drug screen. Applicants must pass all examinations to be considered for appointment.

#### **BAY VILLAGE EXTRA CREDITS:**

Extra credit documentation may be submitted for a maximum of 10 points. Applicants passing the written exam with a score of 70% or higher shall be awarded the additional credit points (below) for higher education, training and/or military service.

<u>The 10 candidates with the highest adjusted scores</u> will proceed through additional further testing at the discretion of the Bay Village Civil Service Commission and the Fire Chief. Additional further testing may include interview, polygraph test, background investigation, psychological exam, and physical exam including drug screen. Applicants must pass all examinations to be considered for appointment.

#### PARAMEDIC JOB DESCRIPTION (Footnote to Fire Fighter job description in online application)

The Fire Fighter/Paramedic position for the City of Rocky River and for the City of Bay Village includes paramedic responsibilities. Approximately 75% of the calls received are for emergency medical aid and involve the following duties, skills, and abilities, in addition to those listed for Fire Fighter in online application:

#### **DUTIES**

- Responds to medical emergencies using rescue squads and medical equipment
- Performs medical procedures to level of certification (administers intravenous fluids, drugs and medications; inserts invasive airways; performs cardiopulmonary resuscitation; performs routine diagnostic testing, e.g., 12-lead electrocardiogram)
- Lifts and carries patients
- Follows protocols set forth by the Medical Director

#### **SKILLS AND ABILITIES**

- Perform medical procedures
- Apply standard emergency aid techniques
- Lift patients and equipment
- Perform strenuous or peak physical activities during emergencies
- Perform medical and rescue activities for prolonged periods of time under conditions of extreme heights, intense heat, cold or smoke
- Respond effectively in emergency and stressful situations
- Follow verbal and written instructions
- Communicate effectively in verbal and written forms
- Establish effective working relationships with co-workers, employees, other agencies, and the general public

#### FIREFIGHTER'S PHYSICAL AGILITY **TEST INFORMATION**

Cuyahoga Community College requires that all of the Tasks must be completed in (7) minutes or less for entrance into the Fire Academy. Check with each city you are applying for to find out their established times for the physical agility.

The firefighter's physical agility test consists of the following tasks over a timed course:

#### TASK 1 - Stair Climb with High Rise Pack

Carry a high-rise standpipe pack (2-50 foot sections of 1 1/2-inch hose weighing 50 pounds) to the third floor of the fire tower. Deposit the hose in the designated location. After Task 2 is completed, this hose will be returned down the stairs to the starting location.

#### **TASK 2 - Hose Hoist**

From a third story window, using a hand motion hoist a 50 foot donut roll of 2 1/2 inch hose (about 50 pounds) connected by 5/8 inch rope. This task will be completed twice.

#### **TASK 3 - Forcible Entry**

Using the Keiser Force Machine, and a nine-pound hammer, drive a steel beam 5 feet.

#### TASK 4 - Hose Advance

Pick up the nozzle and move a 1 3/4-inch charged hose straightforward 75 feet.

#### **TASK 5 - Victim Rescue**

Drag a 175 pound dummy a distance of 100 feet.

Cuyahoga Community College will issue a certificate of completion indicating the time it takes to complete the tasks. The class participants will be responsible for taking their certificate of completion to the jurisdiction for which they are applying. The certificates will be valid for one year. Applicants must be sure that the fire departments where they are applying for a position will accept the certificate as their standard.

#### **Prerequisites for Firefighter Agility Testing**

- 1. Must show photo proof of identification after passing the test. An Ohio Drivers License or State Identification Card is acceptable.
- 2. Must read and sign a waiver of liability.
- 3. Must complete a college non-credit registration form and pay a \$50.00 course fee prior to the test date.
- 4. Must be in excellent physical health. A physician's exam is not required but is highly recommended.

The firefighter's agility testing will be conducted outdoors. Applicants will be required to wear five-pound ankle weights to simulate the weight of firefighter turn out gear. An air tank will be worn during testing for weight only; it will not be used for breathing Applicants can furnish their own gloves or they will be furnished. A firefighter helmet must be worn. Helmets will be furnished. Applicants can furnish their own liner, if they prefer. A ball cap or skullcap will work. It is suggested that applicants wear physical training gear with long pants and athletic shoes with good traction.

Firefighting is physically demanding and at times extremely Candidates are encouraged to do pretesting hazardous. exercises that will assist them in completing the agility test.

Please note: Cuyahoga Community College does not assume any responsibility for any medical consequences that might arise from participating in physical agility testing.
