Thank you for your interest in the City of Sycamore Fire Department. Please read this document carefully, paying particular attention to deadlines and required documents:

# MINIMUM REQUIREMENTS

- \$25.00 non-refundable application fee;
- U.S. Citizen or legally authorized to work in the U.S. (Must meet I-9 requirements);
- High School Diploma or Equivalent;
- Valid Driver's License (valid Illinois Driver's License at time of hire);
- 21 to under 35 years of age at time of application deadline, unless otherwise exempt by statute;
- Proof of completion of Candidate Physical Ability Test (CPAT) and Ladder Climb Test within 12 months <u>prior</u> to the date of the written examination. CPAT/Ladder Climb accepted from:
  - Northeastern Illinois Public Safety Training Academy (NIPSTA) <u>www.nipsta.org</u>
  - Southwest United Fire Districts (SUFD) <u>www.sufd.org</u>
  - Any certifying agency possessing a Limited License by the IAFF/IAFC Wellness-Fitness Initiative
- Certified Illinois Office of State Fire Marshal Firefighter II or Basic Operations Firefighter at time of application deadline;
- Licensed Illinois Department of Public Health Emergency Medical Technician Paramedic (IDPH EMT-P) at time of application deadline;
- Must reside within 20 miles of department within 12 months of hire;
- Completion and submission of online application and all required documents by 4:00 p.m. on Monday, June 30, 2014.

Mannheim Rd., Suite 203, Westchester, IL 60154 before 4:00 p.m. on June 30, 2014. Applications received after 4:00 p.m. on Monday, June 30, 2014 will NOT be accepted. Faxed or postmarked release forms will NOT be accepted. Documents may be delivered by hand or by mail; traceable courier is suggested to ensure timely delivery. Candidates will be notified by Public Safety Recruitment AFTER the deadline via email regarding eligibility status. Public Safety Recruitment is not responsible for late or lost documents. It is the responsibility of the candidate to ensure all paper work is submitted properly by the deadline date.
- 3) Applicants MUST submit proof that they have passed the CPAT and Ladder Climb within 12 months PRIOR to written exam date (7.26.14). CPAT cards and Ladder Climb Certifications are only considered valid if dated from 7.26.13 through 7.26.14. CPAT/Ladder Climb accepted from:

  - Southwest United Fire Districts (SUFD) <u>www.sufd.org</u>
  - Any certifying agency possessing a Limited License by the IAFF/IAFC Wellness-Fitness Initiative

**NOTE:** Candidates who complete the CPAT and Ladder Climb <u>before</u> the application deadline must submit proof of these certifications at application deadline. Candidates who complete the CPAT and Ladder climb <u>after</u> the application deadline must bring photocopies of their certifications to the written examination for sign-in.

4) Attend Mandatory Orientation and Written Exam on Saturday, July 26, 2014 at Sycamore Police Department, 535 DeKalb Avenue, Sycamore, IL 60178. Sign-in begins at 8:00 a.m. You must have a valid driver's license or state ID to sign in <u>AND</u> copy of CPAT and Ladder Climb Certificate if testing after the application deadline. Doors close and testing will begin promptly at 8:30 a.m. Candidates arriving late will NOT be permitted to test. Only candidates who successfully complete the application and submit all required documents properly by the application deadline will be invited to participate in testing.

All portions of the testing process are mandatory. Failure to attend and successfully complete any portion of the process will result in elimination from employment consideration.
